After you have completed a case, you can easily submit it to ACAP for billing with the click of a button.

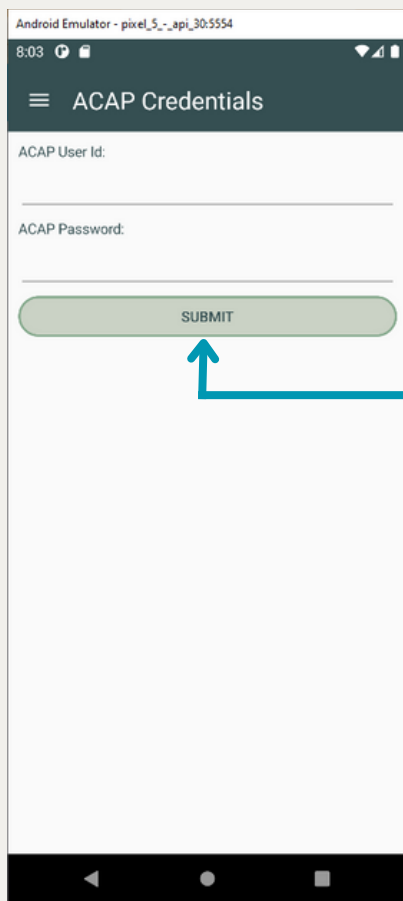

Feature Highlight: ACAP Submittal

Before submitting cases to ACAP for the first time, valid credentials must be specified. Choose “Submit ACAP Credentials” from the main menu. After initial setup, this only needs to be done when ACAP credentials change.

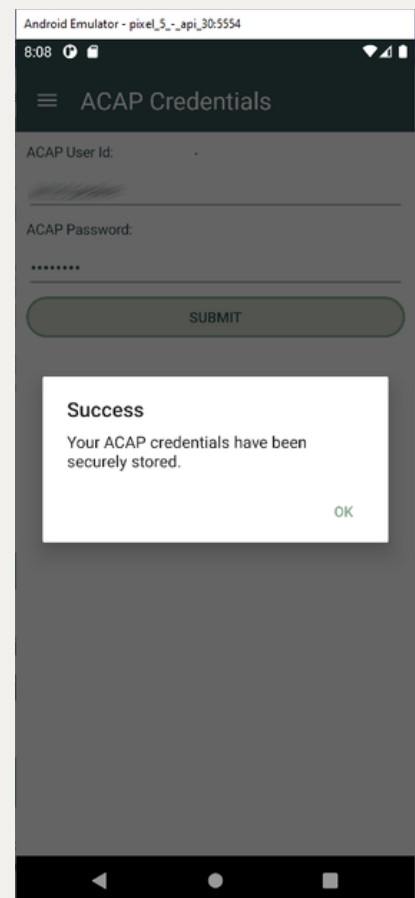
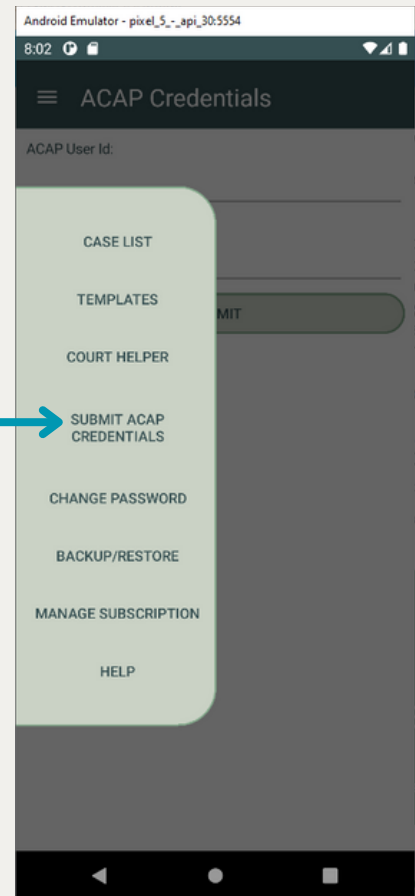

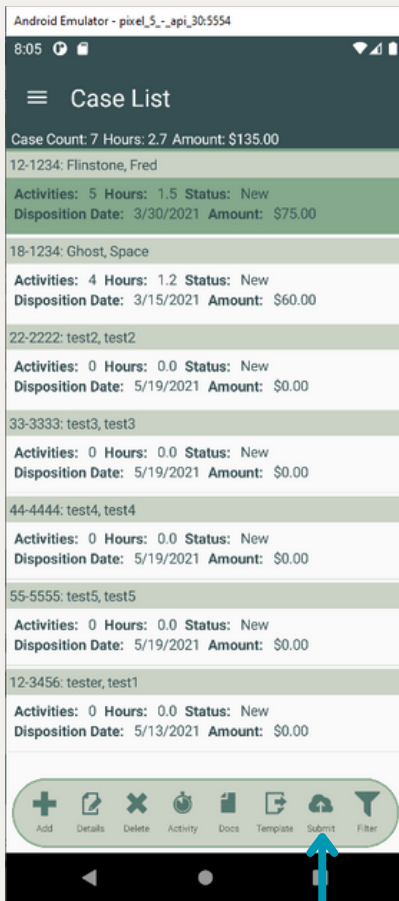
SUBMIT

Enter credentials for your ACAP account and click the Submit button. This securely stores your credentials on the Tabellion server for use in submitting your cases.

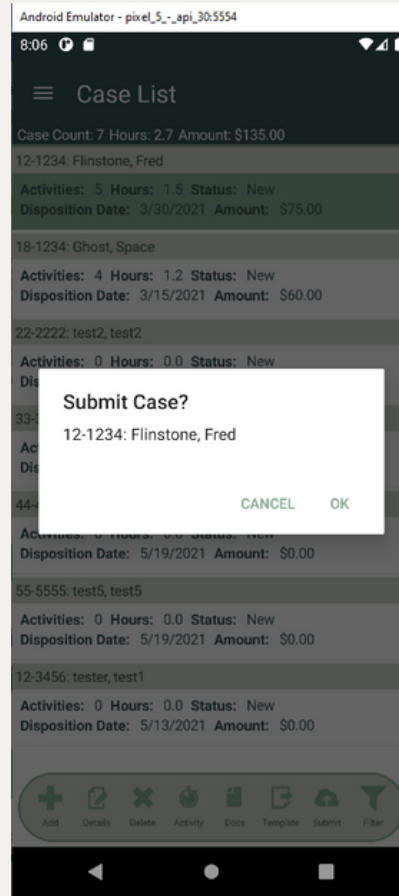


The following notification appears to indicate your credentials were successfully stored. You are now ready to submit cases to ACAP.

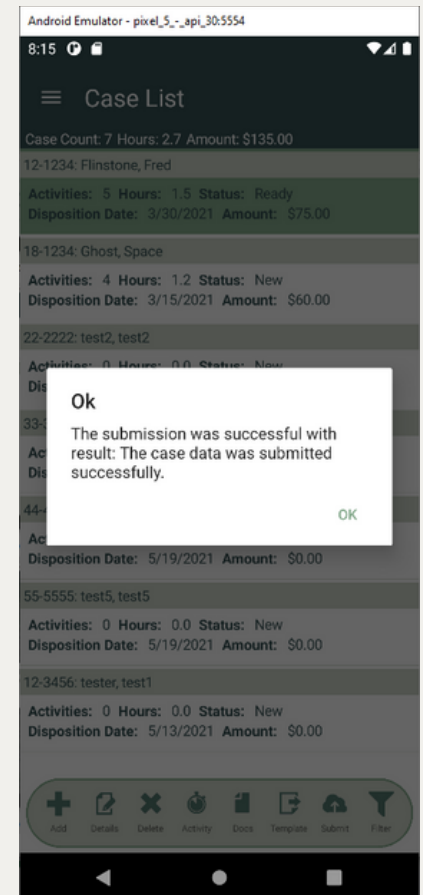
Feature Highlight: ACAP Submittal



Select a case to submit to ACAP. For example, we have selected the Fred Flintstone case. Click the Submit button to submit the case.



Confirm the case is to be submitted.



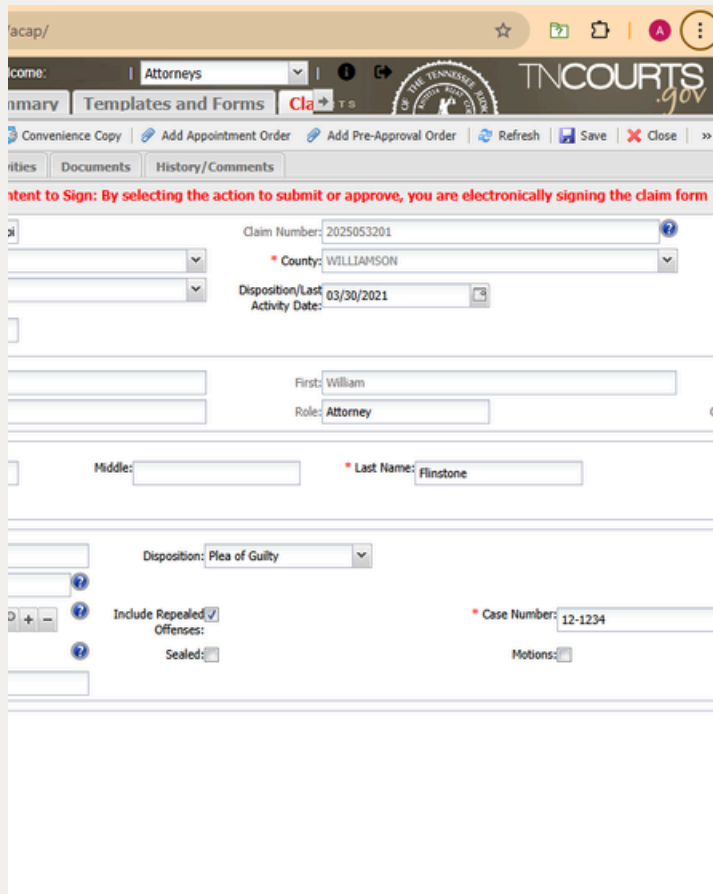
A notification appears confirming the case has been queued for submission. The status on the case will briefly change to “Submitted” and then to “Ready”, which indicates the Tabellion server is processing the case.

Feature Highlight: ACAP Submittal

When the Tabellion server has completed sending the case to ACAP, the status will change to “Complete”. This indicates all information for the case has been sent to ACAP, including activities and affidavit of indigency.
